TERMS & CONDITIONS

1. The sealed bid shall be **received by this office up to 05:00 PM on 05.07.2021**. Any bid received after the prescribed deadline shall not be considered. Tender should be addressed to "The Assistant Director, MP-IDSA, New Delhi" and handed over to the Section Officer in charge of vehicle, MP-IDSA, New Delhi.
2. The bids shall remain valid for a period of 45 days from the date of receipt of the bid.
3. The rates quoted by the bidders for purchase of old serviceable vehicle will be inclusive of all taxes and on "**As is where is basis**". Any statutory or other charges shall be borne by the bidder. The successful bidder will take possession of the vehicles on a date and time specified by this office and will arrange for transportation of the same at his expense.
4. The vehicles will be disposed off on the basis of highest rate. However, this Institute reserves the right to withdraw the vehicle from the bidding process in case the quoted price received is less than the reserved price.
5. The Successful bidder must adhere to the time limit. Failure to deposit the requisite sum before the stipulated date/time entails the forfeiture of the contract as well as bid security amount. After delivery of the vehicles, this Institute will not be responsible for any damages to the vehicle or person.
6. This Institute reserves the right to annul the bidding process at any time prior to award of contract including rejection of any or all bids after the same have been received, without thereby incurring any liability to the affected bidder/s or any obligation to inform the affected bidders on the ground of this office's action.
7. The bidders may physically visit and inspect the Vehicle before putting in their bid. The Section Officer, MP-IDSA, New Delhi may be contacted for inspection of the vehicle. **The inspection of the vehicles may be done from 10:00 AM to 05:00 PM of any working day up to 05.07.2021**. No complaint whatsoever will be entertained after closing of tender. No request for inspection after submission of tender will be accepted.
8. The vehicle shall be handed over to the successful bidder against 100% deposit of offer/ bid value.
9. **Security Deposit** : Successful bidder has to submit 3% of the total bid amount as Demand Draft in favour of "IDSA" payable at New Delhi and the same will be refunded on transfer of registration of vehicle.
10. The bidder has to submit transfer of registration forms alongwith bid form i.e **Annexure 'B'**.

The residual payment has to be submitted by the successful bidder within 7 days of the date of delivery of the order otherwise the offer will be cancelled and bid security amount shall be forfeited.

12. Disputes, if any, shall be subject to jurisdiction in the Court of Delhi only.

13. Tender form should be signed in ink by the authorized signatory only. Photocopy or unsigned quotations or quotations not signed by authorized signatory shall be rejected.

14. Once the release order issued, this office will not be responsible either for safe custody or for any loss or damage to the subject vehicle.

15. In case the bidder is a company, the name of the company should be indicated as the bidder. In such cases the person appearing for the company should have the authorization letter in a proper format issued from a competent authority of the company. Request to change the name of the bidder in the tender after submission of the tender will not be entertained.

16. The sealed tenders superscribed "**Tender for sale of old serviceable office vehicle**" will be opened **on 06.07.2021 at 11:00 A.M** in presence of bidders.

17. The scheduled day for opening the sealed tenders, if declared to be holiday due to any unforeseen reasons, the same will be opened the next immediate working day.


18. The bidders should quote the amount for purchase of the subject vehicle both in words and in figures, if there is any difference between the amounts mentioned in figures and that of in words, the rate quoted in words will be taken in to account and accepted on record.

19. The bidder is required to reveal his full name/name of the authorized signatory of the firm/name of father, full postal address, telephone number & mobile number and GSTIN number, if any.

20. The person authorized by bidder will be allowed to take the delivery. The bidder is required to produce any of documents as documentary evidence for proof of their address (Ration Card /Voters Identity Card in case of individual and Registration Certificate in case of firms etc.).

21. The successful bidder will also be responsible for getting the Registration Certificate of the vehicle transferred in his name at his own cost expeditiously. This office will not be responsible for any lapse on his part in this regard.
