# Guidelines for Contributors

The *Journal of Defence Studies* is a quarterly, refereed research periodical published by the Manohar Parrikar Institute for Defence Studies and Analyses, New Delhi. It seeks to encourage further research on the core issues of defence, provides the latest perspectives, and serves as a platform for sharing research findings and opinions of scholars working on defence-related issues.

The Journal contains a mix of research articles, essays, topical commentaries, opinion pieces and book reviews. Each issue includes articles on varied themes affecting the Indian Armed Forces, including emerging security threats and scenarios; civil-military relations; higher defence planning; doctrines and concepts; organisations and structures; command and control mechanisms; logistical support and sustainability issues; budgeting procedures and practices; and other related issues in the area of defence and national security. The Journal would also focus on issues concerning defence policy, reforms in defence sector, and defence economics.

# SUBMISSION OF ARTICLES

The Journal welcomes a variety of contributions:

- 1. full-length analytical articles ranging between 6,000-8,000 words;
- 2. commentaries/perspective pieces between 2,000-3,000 words;
- 3. review essays of around 4,000–5,000 words; and
- 4. book reviews of around 1,500 words.

Authors are requested to submit their papers to the following email id: jds.mpidsa@gov.in. All correspondence between the Journal editorial team and authors and reviewers will be conducted via email.

Submission of an article implies that the work described has not been published previously, that is it not under consideration for publication elsewhere, that its publication is approved by all authors and that, if

accepted, it will not be published elsewhere in the same form without the written consent of the copyright holder.

Upon acceptance of an article, authors will be asked to sign a 'Journal Publishing Agreement'. If excerpts from other copyrighted works are included, the author(s) must obtain written permission from the copyright owners and credit the source(s) in the article.

## IMPORTANT INFORMATION REGARDING SUBMISSIONS

Authors should take care to ensure that their submissions follow all style/ reference guidelines as required by JDS. Any submission that does not conform to these guidelines would not be taken up for discussion with the JDS Editorial Committee.

#### REVIEW

The articles will be peer reviewed/refereed before final selection for publication. The Editor reserves the right to make a final decision on publication as well as the right to make alterations. Selected contributors will be informed of the selection of their paper/article via email.

#### **COPYRIGHT/AUTHOR'S RIGHTS**

The copyright of the Journal rests with the MP-IDSA. As an author you retain certain moral rights on the work and can use or disseminate it—with the permission of the copyright holder—for scholarly and for research/teaching purposes.

# FORMAT FOR ARTICLES

We accept articles in MS WORD (2003/2007 and newer versions). The text should conform to the following:

- The text should be in English (preferably British spellings, for example, analyse, specialisation, 'labour', 'mould', etc.).
- The text should be in 1.5 spacing with standard margins.
- Use single quotation marks consistently; double quotes to appear when indicating quoted matter within quoted matter.
- References to be inserted as notes.
- Tables/Figures/Maps/Boxes/Images to be numbered sequentially; also give appropriate captions and place call-outs in text.

# TITLE PAGE

Provide the following data on the title page (in the order given):

- *Title/Subtitle:* This should be concise and informative.
- *Author names and affiliations:* We will require the full postal address of each affiliation, including the country name, and the e-mail address of each author.
- *Corresponding author(s):* Ensure that email/contact details such as telephone and fax numbers (with country and area code) are provided in addition to the e-mail address and the complete postal address.
- *Abstract:* A concise and factual abstract (between 100–150 words) is required to be submitted along with the article.
- 4–5 Keywords.

### SUB-HEADS/LEVEL-HEADS

Divide your article into clearly defined (or numbered) sections/subsections.

#### ACKNOWLEDGEMENTS

Collate acknowledgements in a separate section at the end of the article.

## References

Responsibility for the accuracy of bibliographic citations lies entirely with the authors. All references/citations should be clearly mentioned in the notes (footnotes/endnotes) in the format listed below.

Each reference should be clearly inserted as a footnote with the corresponding in-text cue. Additional references should be listed after at the end as 'Additional References'. In case of Web references, as a minimum, the full URL should be given as well as the date on which the URL was last accessed.
