Trade and travel across the LoC which was suspended for weeks finally resumed in mid-February when both sides agreed to release the stranded trucks. The Indian authorities released all trucks except for the driver of the truck which was allegedly caught trafficking narcotics from across 'AJK' (Azad Jammu and Kashmir). The breakthrough could be achieved only after hectic parleys were held between the two sides. Notably, trade and travel remain suspended since January 19, 2014 after a driver from the 'AJK' side was arrested by the Jammu and Kashmir police for carrying narcotics in his vehicle. The spill over effect of the standoff on the LoC was still showing in the month of February. The crisis continued even after several rounds of talks were held between the Indian officials and the Pakistan authorities. In the wake of the crisis, there were added checks at the trade centers which further miffed the traders. The entire process of checks and cross checks threatened to damage the traded items. The traders resisted such stringent checks alleging this would incur them financial losses as the goods would be damaged even before reaching the destination.

Meanwhile, India failed to convince Pakistan on establishing banking facilities to cater to the cross LoC trade which presently works on barter system. This was stated in the Economic Survey of Jammu and Kashmir 2013-14, tabled before the Jammu and Kashmir assembly. According to the report, a representative from the Reserve Bank of India (RBI) made a representation before the Joint Working Group meeting but the idea failed to fructify.

On the other side, the boundary issue between Khyber Pakhtunkhwa and Gilgit Baltistan has surfaced yet again. This time around the Karakoram Highway was blocked for traffic after residents of Kohistan confiscated over 400 goats, belonging to a man from Diamer, grazing in a disputed area claimed by both Khyber Pakhtunkhwa and Gilgit Baltistan.

"Removal of key officials: Govt rejects AJK PM's recommendation"

MUZAFFARABAD: Establishment Division has turned down Azad Jammu and Kashmir (AJK) Prime Minister Chaudhry Abdul Majeed's recommendation to take back the services of the AJK Chief Secretary Khizar Hayat Gondal and Inspector General of Police (IGP) Malik Khuda Bakhsh Awan, official noted.

The official sources further stated the Establishment Division in reply to the letter of the AJK Prime Minister Chaudhry Abdul Majeed refused to take back the assignments of Gondal and Awan saying the subject was not related to the AJK premier's office and both the officers would continue the duty as per their portfolio. On February 23, AJK PM Majeed had written a letter to the federal government to take back the services of the two powerful officers of the state. Majeed, in his letter to the Establishment Division, accused the chief secretary and inspector general of police of violating the chain of command and rules of business.

"Contesting the law: G-B's apex court admits petition against services tribunal"

GILGIT: The chief court of Gilgit-Baltistan (G-B) has admitted a petition challenging recently made appointments in the G-B services tribunal. "Notices have been issued to the chief minister, governor and others for a regular hearing," stated G-B Supreme Court Bar Association President Advocate Shahbaz Khan on February 27. "We have also challenged the ordinance that led to the appointments." The petition was filed jointly by lawyer bodies, including the Supreme Court bar, High Court bar, Skardu district and Gilgit district bar associations, pleading reversal of the appointments and the ordinance. G-B Governor Pir Karam Ali issued an ordinance, establishing the first ever services tribunal in G-B. Through the ordinance, former bureaucrat Hafizur Rahman was made its chairman and two others district judge Khurshid Alam and bureaucrat Fida Hussain were made its members.

Asim Qadeer Rana, "In-house change in AJK Legislative Assembly likely"

ISLAMABAD: An in-house change in the Azad Jammu and Kashmir Legislative Assembly may be on the cards as the PML-N led federal government is coming under severe pressure these days from its AJK chapter as well as PPP splinter group to have the incumbent Premier Ch Abdul Majeeed replaced with another jiyala. Recently, Azad Jammu and Kashmir (AJK) and the Federal Governments locked horns over the removal of the chief secretary and IGP of AJK after an election controversy emerged in one of the constituencies of the AJK assembly as PML-N won the seat.

This situation, sources stated, has led to escalation of tensions between the federal and AJK governments. Sources stated that PML-N President AJK Raja Farooq Haider along with 12 legislators of AJK met with Dr Asif Karmani, Political Secretary of PM Nawaz Sharif, and submitted their written reservation and complaints on the ongoing issues in AJK, and the way state of affairs of the government were being handled.

ISLAMABAD: Opposition parties in the Senate on February 27 blocked the proceedings of the house for the second consecutive session, leaving all but the question hour pending. In the Opposition dominated upper house, members of opposition parties protesting the termination of service of contractual employees and alleged rigging in bypolls in a constituency of Azad Jammu and Kashmir staged a walkout and pointed out the lack of quorum. Only 13 members were sitting on the treasury benches when the headcount was made. The chairman rang the bell for five minutes, but treasury failed to gather even one-fourth of its strength in the 103-member upper house. This forced the chair to adjourn the session for a second time.

"Opposition walks out of Senate over minister's AJK speeches"

ISLAMABAD: The combined opposition in Senate staged a walkout on February 25 against the speeches of Federal Minister for Kashmir Affairs Barjees Tahir during election campaign in Azad Jammu and Kashmir. Leader of opposition in Senate Aitizaz Ahsan told senators that during the recent election in AJK, the minister issued "irrelevant statements". He stated that AJK prime minister wrote a letter to his Pakistani counterpart and asked for the removal of chief secretary and AJK IG because of interference in some government affairs relating to holding of elections. But he regretted that the Pakistan government did not call these two top officials from the AJK.

Aitzaz stated that two Pakistan People's Party workers in AJK were killed during clashes with PML-N workers but no action was taken against them. He demanded the government to clarify its position. However, when leader of the House Raja Zafarul Haq told the House that Kashmir Affairs Minister Barjees Tahir will brief the House in detail. But Aitizaz Ahsan stated, "We will not hear him and leader of the house has to brief the House". Aitizaz announced a walkout when his request was not entertained. He was supported by all the opposition parties.

Ameer Jamaat-e-Islami lauded the role of Minister in bringing good governance and eliminating corruption from AJK and lauded posting of reputable Chief Secretaries and IG Police in AJK and GB. Abdul Rasheed Turabi brought into notice of Minister the culture of a huge cabinet in AJK government when there are economic challenges. He mentioned mushrooming growth of universities and Medical Colleges in AJK and also irregularities going on in these institutions regarding appointments.

Responding to a string of charges aired by Leader of Opposition Aitzaz Ahsan, he contended that AJK PML-N President Farooq Haider was approached by some PPP elements for removal of Prime Minister Abdul Majeed, who toeing Prime Minister Nawaz Sharif's policy of non-inference, declined to support them.

"PML-N demands early elections in AJK"

MIRPUR: Demanding fresh elections, the PML-N leaders in Azad Jammu and Kashmir denied the allegation levelled by the AJK prime minister that the bye-election was rigged through the deployment of paramilitary troops of Rangers on the polling day. Addressing a joint press conference, they were of the view that the recent victory of their party in the bye-election held in Sudhanoti district was primarily due to people's confidence in its leadership and unpopularity of the PPP-led AJK government.

PML-N AJK Secretary Finance Ch Muhammad Saeed, former minister Ch Rukhsar Ahmed, Ch Maalick, Nazir Inqlabi and Tahir Mirza called upon AJK Prime Minister Abdul Majeed to immediately step down by accepting his party's defeat in the byepolls held on February 22 in Baloch (LA-22) constituency following "the ill-governance, extremely corrupt government and malpractices on the part of the sitting AJK ruling clique".

Later, the enraged demonstrators torched the Baloch police station and blocked the main highway, sources stated. Police stated that PPP workers were agitating against the alleged rigging in the by-poll, when a clash started between the workers of PPP and PML-N that soon turned ugly by firing in the melee killing one PPP activist. PML-N candidate Faruque Ahmad was declared the winner in the LA-22 Poonch-6 by-poll.

"AJK SC orders amendment to Public Service Commission Act"

MIRPUR: The Supreme Court of Azad Jammu & Kashmir declared all the AJK presidential ordinances related to the Public Service Commission null and void, and stressed a need for adopting merit for induction of proper persons in the commission. An apex court bench comprising

Chief Justice Muhammad Azam Khan, Justice Muhammad Ibrahim Zia and Justice Raja Saeed Akram issued these orders while dismissing the appeals filed by the AJK government and the AJK Public Service Commission against the recent judgment of the AJK high court whereby the AJK HC had declared that all the AJK president has no power to re-enact any ordinance after expiry of the stipulated period of four months. Thus, the SC upheld the orders of the AJK High Court to this direction.

MIRPUR: Alleging massive rigging in by-elections to AJK Legislative Assembly LA-22, former AJK prime minister and Muslim Conference Chief Sardar Attique Ahmed Khan on February 25 demanded a high level commission to probe the rigging and killing of a People's party activist in a protest against the rigging in Baloch Town a day after the election. GILGIT: The first ever service tribunal of Gilgit-Baltistan (G-B) has become controversial after lawyers termed its appointments 'illegal'. The G-B Assembly passed the service tribunal law two years ago after which it was referred to G-B Governor Pir Karam Ali Shah for approval. The governor signed it on February 21, 2014 officially establishing the first ever service tribunal of G-B. Through an ordinance, a former bureaucrat Hafizur Rahman was made its chairman while district judge Khurshid Alam and former bureaucrat Fida Hussain were made its members. "We demand the ordinance be withdrawn and the appointments reversed," stated G-B Supreme Court Bar Association President Shahbaz Khan on February 23. "The appointments were made overnight to accommodate men of their own choice," Khan stated, referring to the service tribunal's members. He added under the original law, enacted by the assembly, it was mentioned that a high court judge or a senior lawyer should be chairman of the tribunal but that part was removed from the ordinance.

"AJK By-Polls in LA-22 held in peaceful manner"

MIRPUR: The bye-elections of AJK Legislative Assembly seat LA-22, in Sudhonoti district of Azad Jammu Kashmir was held on February 22 in a peaceful manner except the minor incidents at some polling stations. "Borderline: Boundary issue flares up again, KKH blocked"

GILGIT: The row over the territorial boundary between Gilgit-Baltistan (G-B) and Kohistan

district has flared up once again, leading to suspension of traffic on Karakoram Highway (KKH). "This time the issue has come up again because residents of Kohistan forcibly took away more than 400 goats from a resident of Diamer. The goats had been grazing on a piece of land to which both regions lay claim," stated Faizullah, a resident of Chilas. The incident irked residents of Diamer valley and led to protest in the area which resulted in blocking the highway. "The people were already upset over the claim from Kohistanis; the act of stealing of goats has added fuel to fire," stated Mujeebur Rahman, another resident. The status of nearly 10 kilometers of land on both sides of the Basari check post which separates the two regions is not clear and often leads to unrest between people of Diamer and Kohistan. This piece of land has become the bone of contention between residents as it involves compensation and royalty in the longer run.

Salman Abduhu, "Inquiry on to find irregularities in dam land acquisition"

LAHORE: As the Gilgit Baltistan Commission has failed to probe irregularities in Diamer Bhasha Dam land acquisition process despite the lapse of two years' period, Prime Minister Nawaz Sharif ordered a fresh inquiry into multi-billion rupees scam involving several big names and influential personalities. Officials in Water & Power Ministry noted that the government of Gilgit Baltistan had constituted a commission back in January 2012 to probe wrongdoings in 486 kilometer stretch of barren land identified for Diamar-Bhasha dam construction and which had been declared fertile land to increase the compensation amount for land owners. The commission was to investigate the case against Gilgit Baltistan revenue department officials, including tahsildars as well as patwaris, who were reported to be involved in dam corruption scandal.

Shabbir Mir, "'Accept or pack up': Charter of demands presented for Diamer-Bhasha Dam"

GILGIT: Residents of Diamer have warned to end support for Diamer-Bhasha Dam if the rights of locals are not upheld as per their wishes. The Diamer Action Committee (DAC) presented a 37point charter of demands in a news conference on February 18 and asked the government to 'accept them or pack up'. "The demands we have presented are genuine and directly linked to the future of the dam," stated Ahmad Alam, president of DAC, a body which represents a majority of villages from Diamer. "We would not allow anyone to deprive us of our rights and the government will have to accept our demands or just leave our area," he added. DAC's charter of demands calls for a revision of the prices of land being acquired by the government for the construction of Diamer-Bhasha Dam in Diamer Valley. It also demands that residents of Diamer be given employment opportunities in the dam's construction on a priority basis.

Faisal Raza Khan, "Gold panning leaves toxic mercury trail in Pakistan"

ISLAMABAD: A three-year project to study gold ore in Pakistan's northern areas in collaboration with the US has discovered new deposits of the yellow metal as well as concentrations of toxic mercury spilling into the environment from primitive extraction methods. "During research for the US-Pakistan 'gold mineralisation' project, hyper-spectral remote sensing and geo-chemical analyses were used besides field work," says Shuhab Khan, associate professor of geology at the University of Houston. "Although most of northern Pakistan is known to have gold deposits, the new findings in Astore (in the Gilgit-Baltistan region) are significant and need extensive research with a view to safe extraction," Khan noted.

MUZAFFARABAD: Azad Jammu and Kashmir Supreme Court (AJKSC) on February 13 declared the appointment of Azad Jammu and Kashmir Public Service Commission (AJKPSC) Chairman Mumtaz Hussain Naqvi and its nine members illegal. A full bench of AJK Supreme Court headed by Chief Justice Muhammad Azam Khan gave its verdict on separate appeals filed by the AJK government and the Public Service Commission against the high court decision of September 10, 2013 in which the PSC, under the chairmanship of Mumtaz Naqvi, was declared illegal.

The SC in its judgment stated the appointment of the PSC chairman and its members was made through an ordinance. It is necessary that such appointments be presented in the Legislative Assembly within 120 days and this has not been done in this case. The bench urged the government of AJK to ensure

appointments on merit and stated the government in AJK should follow the process laid out by the Federal Public Service Commission.

MUZAFFARABAD: All but one of the 76 truck drivers who had been stuck on opposite sides of the Line of Control (LoC) since January 17 following a row over alleged drug trafficking from Azad Kashmir returned to their respective sides along with their vehicles on February 12, officials stated. On January 17, 49 trucks from AJK and 27 from J&K ferried goods to opposite directions. However, after India alleged that it had seized 114 packets of heroin from one of the consignments and arrested the driver concerned, all 76 trucks got stuck on opposite sides. The crossings took place between 5:45 pm and 7:15 pm through the Chakothi-Uri point under a decision taken by the foreign ministries of India and Pakistan, they added.

On Jan 17, 49 trucks from AJK and 27 from Indiaheld Kashmir ferried goods to opposite directions. However, after India alleged that it had seized 114 packets of heroin from one of the consignments and arrested the driver concerned, Mohammad Shafique, all 76 trucks got stuck on opposite sides. Due to the standoff, not only trade but travel from both crossing points also came to a halt. The trans-LoC travel recommenced on February 3, but deadlock on trade could not end because AJK authorities wanted the return of all 49 drivers, including Mr Shafique, who they believed was not guilty.

"AJK hydropower potential yet to be surveyed:WBreport"

ISLAMABAD: While the government is in the process of initiating major projects in the power sector, the potential of 6,000 megawatts (MW) hydropower in Azad Kashmir roughly equivalent to the entire national power deficit has not yet been surveyed, revealed a World Bank report. The 'Azad Jammu and Kashmir Consultations Report' released by the World Bank says that in terms of priorities, there are over 8,000MW of hydro potential in AJK, out of which 6,000MW has not yet been surveyed. "This will be 'clean' source and not a drain on the foreign reserves," the report comments. There are eight small potential hydropower projects proposed by the AJK government for funding that can be completed in the short-term and brought on the grid with private sector support, according to the report.

Abdul Rasheed Azad, "Education, health and development sectors: China pledges to complete \$353 million projects in quake-hit AJ&K"

The government of China has pledged to complete 37 projects in education, urban development, health and infrastructure sectors, costing \$353 million equivalent to Rs 34.594 billion in earthquake-hit areas of Azad Jammu and Kashmir (AJ&K). This was stated by Director General Urban Development, Earthquake Reconstruction Rehabilitation Authority (Erra), Brigadier Zafar Wahla (Retd), adding that the authority had completed 9,580 out of 14,513 projects and was committed to complete rest of on-going urban development projects in Khyber Pakhtunkhwa and AJ&K earthquake-hit areas on priority basis.

Wahla, while briefing the media person who visited the Muzaffarabad city to observe Erra's different completed projects, stated 10 mega projects had been completed while rest of 37 were under construction on fast track basis. He added that 12 more mega and small projects would be launched in a couple of months.

"Miacher Valley: And the slopes keep cracking from side to side"

GILGIT: Cracks in the slopes of Gilgit-Baltistan's (G-B) Miacher valley have widened in a week's time. This is a new development giving rise to fears of an imminent disaster. Located about 70 kilometres from Gilgit, the mountain slopes in Miacher Valley are laden with cracks that seem ready to give way. Failure of the slopes is expected to block Hunza River and drown many adjacent settlements in its wake. "The cracks are about 50 to 250 metres in length in the lower strata of the rocks

and have shown an abrupt increase of two to three inches in the last week," stated Mujahid Ali Shah, a professor at Karakoram International University. Shah, a landscape ecologist trained from the University of Greifswald, has warned of a disaster 10 times worse than the one that struck Attabad four years ago and killed 19 people.

GILGIT: As ecologists fear a natural disaster if the cracked slopes in Miacher Valley give way, the chairman of the National Disaster Management Association (NDMA) says there is nothing to worry about. Maj Gen Saeed Aleem claimed the widening cracks in the slopes of Gilgit-Baltistan's (G-B) Miacher Valley do not pose as an immediate threat to the residents. "The situation is not grave enough to threaten the residents in Miacher Valley nor does the situation warrant enforcement of emergency," read a press release issued after the chairman's meeting with G-B Chief Secretary Younus Dagha. Located about 70 kilometres from Gilgit, the slopes of Miacher are developing dangerous cracks. It is feared if these widen further, a disaster far bigger than the one that struck Attabad four years ago, killing 19 people, could follow.
