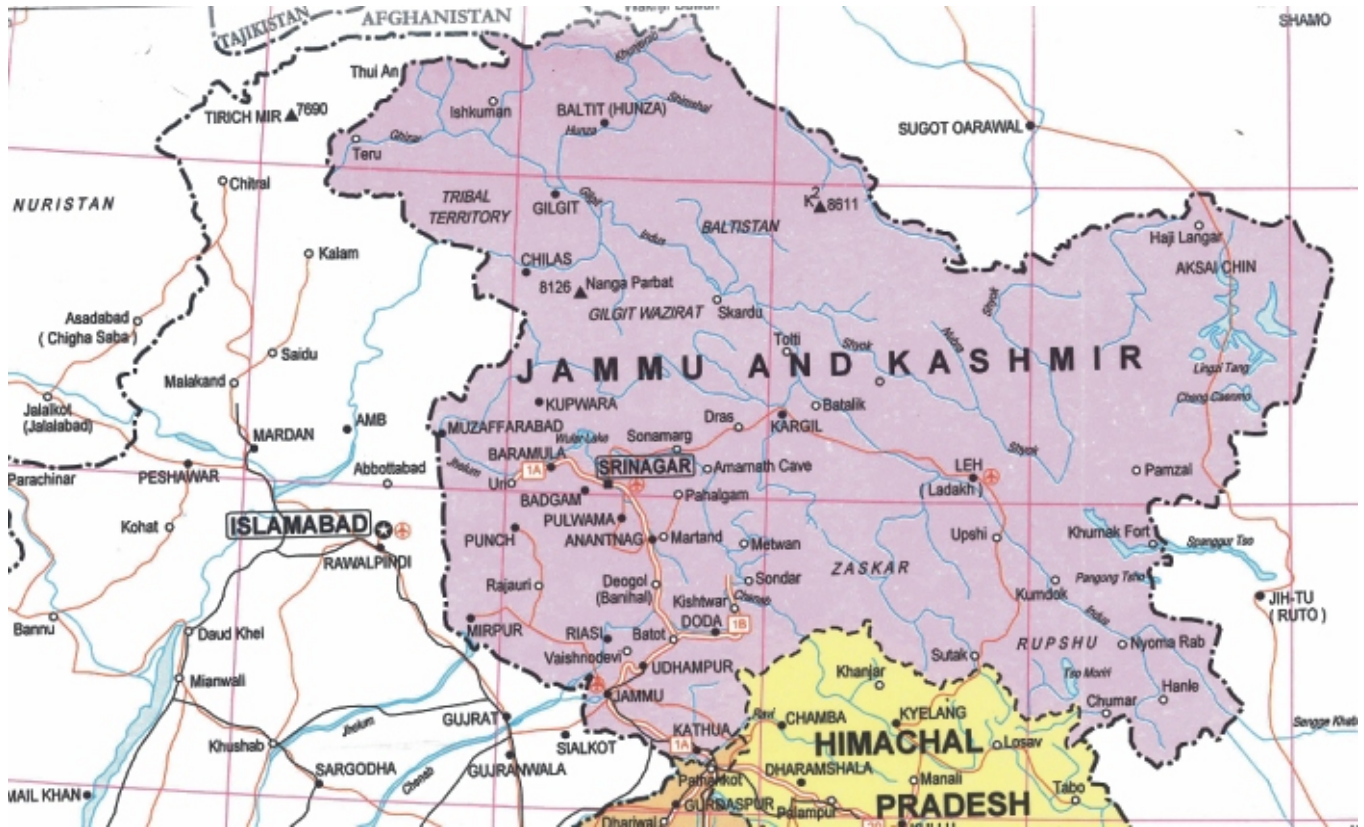

## In this Edition

*Ever since the China Pakistan Economic Corridor (CPEC) was announced to be built with a whopping \$ 46 billion (via Gilgit Baltistan), there have been widespread concerns in the Gilgit Baltistan region on whether the local population will get a share in the benefits accruing from the billion dollar connectivity and infrastructure projects. Such concerns have been conveyed to the leadership in Pakistan by representatives from the region. Gilgit Baltistan has been under political subjugation for over six decades as Pakistan has deliberately subjected its political fate to the final resolution of the Kashmir issue. Similarly, the region is neither part of Pakistan's constitution nor does have a constitution of its own. This is unlike the so called Azad Jammu and Kashmir (AJK) which is currently ruled under an interim constitution introduced in 1974.*

*As a measure to curb growing local apprehensions, the government of Pakistan decided to include the incumbent Chief Minister of Gilgit Baltistan, Hafeez ur Rehman in a committee that was constituted to derive national consensus on the CPEC. As indicated in a report included in the current issue, the decision to induct the Chief Minister of Gilgit Baltistan was taken at a meeting between Rehman and Senator Mushahid Hussain, Chairperson of the Parliamentary Committee on CPEC. Rehman's induction is seen as a step to tide over the unrest that stemmed from Pakistan's gross neglect of Gilgit Baltistan till now in all issues concerning CPEC. According to the understanding reached at the meeting, either the Chief Minister himself or his nominated person will participate in all meetings relating to CPEC that would be held both inside Pakistan and abroad.*

*Mir Ghazanfar Ali Khan was appointed as the next Governor of Gilgit Baltistan. Khan is known to the PML-N (Pakistan Muslim League-Nawaz)-led ruling establishment in Islamabad, and is especially close to Prime Minister Nawaz Sharif. He took over from Chaudhary Muhammad Barjees Tahir, Minister of Kashmir Affairs and Gilgit Baltistan (KAGB) who was simultaneously holding the charge of Governor of Gilgit Baltistan.*

## **“‘AJK’ to resolve overseas issues”**

Along with other government officials, Rahman laid wreaths on the graves of war heroes who had fought valiantly in the armed struggle against Dogra rule, liberated the region and announced accession of G-B to Pakistan on November 1, 1947.

## **“Two SCO employees kidnapped from Diamer”**

Two employees of the Special Communication Organisation (SCO) were kidnapped from the Derail Valley of Diamer District. According to police sources, at least a dozen alleged terrorists

took part in the kidnapping incident. They reportedly tied the watchman of the cellular company's tower with ropes and took the two SCO employees namely engineer Essa, resident of Gilgit and operator Amjad Hussain, resident of Astor along with them. The SCO, which is part of the Pakistan Army, is providing telecommunications services in the region. Inspector General of police Gilgit-Baltistan Zafer Iqbal Awan visited the area and launched a search operation in the Darail Valley of Diamer District. Member GBLA Muhammad Shafi raised the issue in Gilgit-Baltistan Legislative Assembly. He stated that this was the result of negligence and failure of G-B police as well as the G-B provincial government. "Kidnapping of army employees is a serious issue," he further added. Speaker Gilgit-Baltistan Legislative Assembly constituted a seven-member parliament committee comprising Opposition leader Haji Shah Baig, Deputy Speaker Jafarullah, Minister Works Dr Iqbal, Minister for Forest Muhammad Wakeel, Minister for Excise and Taxation Ferman Ali, Minister for Food Haji Janbaz Khan and member Haider Khan to investigate the incident.

### **"GB government warned of TTP attack"**

The Interior Ministry warned the Gilgit Baltistan (GB) government that proscribed Tehreek-e-Taliban Pakistan (TTP) can attack and kidnap security forces to release terrorists involved in Nanga Parbat and Chilas incidents. The interior minister wrote a letter to the provincial government warning that TTP 'Hameed' group was planning an attack in the area. The letter stated the terrorists may also target police stations and jails. The GB government has been instructed to take all the necessary steps for ensuring security of important government installations. In 2013, terrorists in guise of security forces killed nine foreign tourists including a local guide at the Nanga Parbat base camp. Five of the culprits were apprehended while seven were declared as proclaimed offenders.

### **"Lawmaker Rehana Abbadi demands security from G-B govt"**

Rehana Abbadi, a lawmaker in Gilgit-Baltistan, has demanded security from the government as she is receiving death threats. The request was made through a motion moved in Gilgit-Baltistan Legislative Assembly on the third day of its proceedings on November 5. "I belong to a religious family and have been receiving threats from opponents," she informed the house. "I strongly urge the government to provide me with security. If they fail to do so, the government will be responsible for whatever happens to me." Abbadi is a member of Islami Tehrik Pakistan (ITP) and was elected on a women's seat in June 2015. She is among the six women lawmakers in the 33-member legislative assembly. "I have been attacked by my opponents in the past as well," she stated. "However, the government did not take measures to ensure my security."

### **"Environment act to be passed in G-B Legislative Assembly"**

An environment act will be passed in the next session of the Gilgit-Baltistan Legislative Assembly to ensure that work on the China-Pakistan Economic Corridor project does not have a negative impact on the region. This was stated by G-B Parliamentary Secretary for Law Aurangzeb Khan on November 7 at a press conference in Gilgit. "We will pass the act to ensure the environment remains unaffected during the massive construction expected for CPEC," stated Aurangzeb. "This is one of the four acts we presented in the assembly recently and hopefully the house will pass it in the next session."

Mega construction is envisaged for the economic corridor that aims to connect Gwadar Port, in the southwest of Pakistan, with China. Aurangzeb also spoke about the recommended increase in the salaries of lawmakers, noting the demanded

increase is less than what their counterparts in the rest of the countries were enjoying.

### **“Rahman offered a seat at CPEC table”**

The chief minister of Gilgit-Baltistan will be kept in the loop for all activities related to the China-Pakistan Economic Corridor (CPEC). “This was decided in a meeting between the chairperson of the parliamentary committee on CPEC, Senator Mushahid Hussain, and G-B CM Hafeezur Rahman,” noted an official on November 10. Hussain is chairing the committee on CPEC, which was constituted recently to develop a national consensus on the \$46 billion economic corridor to join China's south-western region with Gwadar Port. According to the official, the two politicians also met in Islamabad on November 10 to settle matters. The announcement is considered an important step to bring stakeholders of the region on board where lawyers and politicians raised hue recently over neglecting G-B in the project. According to the official, either the CM or his nominee will represent G-B in all meetings and events taking place at a national or international level. CM Secretariat's spokesperson Sajjadul Haq stated an international conference will be organised next year in China to attract investment for G-B. “This conference is an outcome of the CM's meeting with Hussain in Islamabad,” noted the spokesperson. He added G-B's Karakoram International University will sign agreements with China's Sinkiang University to encourage research on CPEC and learn the languages of respective counterparts.

### **“KNP asks Pakistan to stop harassing Kashmiri leaders in PoK”**

In a letter to Pakistan High Commissioner to the UK, Syed Ibne Abbas, the Kashmir National Party (KNP) has raised the issue of harassment of its workers in Pakistan occupied Kashmir (PoK). Dr

Shabir Choudhry, Diplomatic Head of Kashmir National Party, noted in a statement, “We are seriously concerned about growing intolerance and curbing of political and economic rights in Pakistani Administered Kashmir and Gilgit Baltistan”. It added, “We strongly oppose violence, religious intolerance and terrorism in any form or shape; and promote our struggle peacefully. This right is granted to us by the UN Resolutions on Kashmir, the UN Charter and the Constitution of Pakistan”. Dr. Choudhry has written to Pakistan High Commissioner that despite peaceful struggle the Kashmiri leaders and political workers in Azad Kashmir are systematically targeted and harassed under the cover of National Action Plan. In December 2014, Pakistan announced a national plan to fight terrorism.

A special military tribunal court to handle terrorism cases in the country was also formed a week after the deadly attack on a military school in Peshawar that killed 149 people, 133 of them children. However, political activists in Pakistan occupied Kashmiri alleges that in the shade of NAP, Pakistani forces are harassing them.

### **“Gilani seeks provincial status for AJK, G-B”**

Former chief justice of the Azad Jammu and Kashmir (AJK) Supreme Court has sought provincial status for the two disputed territories of Azad Jammu and Kashmir (AJK) and Gilgit-Baltistan (G-B). Justice (retd) Manzoor Hussain Gilani, chairman of the Association for the Rights of People of Jammu and Kashmir, noted that both G-B and AJK are parts of the disputed state of Jammu and Kashmir, under control of Pakistan. He stated the present de-facto provincial arrangements in G-B and AJK need to be formalised in the Constitution. The lack of this formalisation has hampered the commitment of the Pakistani government, and retarded democratic growth of the areas, while denying them their legitimised status under the country's constitution, he stressed. “Both territories need similar, simultaneous constitutional reforms to

be empowered as 'special territories of Pakistan akin to provinces', with representation in all policy and decision-making institutions under the Constitution," Gilani stated.

### **“Tripartite talks stressed to solve Kashmir dispute”**

Speakers called for early peaceful settlement of the Kashmir issue in line with the aspirations of the people of Jammu & Kashmir without further delay through tripartite talks among Pakistan, India and the people of Kashmir. Speaking at a reception hosted in his honour on November 11 by Central Senior Vice Chairman J&K Peoples National Party Zulfiqar Ahmed Raja Advocate, Gilgit/Baltistan Legislative Assembly member Nawaz Khan Naaji stated that Jammu & Kashmir state, comprising five units of AJK, GB, Jammu and Kashmir and Ladakh regions, is inalienable entity and no power on earth could divide. Former chief justice of AJK High Court and President Jammu & Kashmir Liberation League Justice (Retd) Abdul Majeed Mallick, ex Mirpur District Bar Association Presidents Sardar Ejaz Nazir Advocate and Azeem Dutt Advocates, Aslam Watnoof, Amin Beg Advocate and others also addressed the ceremony.

They stated that people of Jammu & Kashmir from across the LoC should be included in the composite dialogue between India and Pakistan to ensure the early resolution of the decades old Kashmir dispute in line with the aspirations of the people of the state. The speakers noted that international community including America and the western world were also showing keen interest for the early peaceful solution to Kashmir issue.

“It could be assessed through the fact that major powers including United States and the western world are stressing for the early peaceful solution to the issue through meaningful dialogue between India and Pakistan.

### **Arshad Shaheen / Khalid Qayyum, “Increasing interference: AJK to lodge protest with federal govt”**

The Pakistan People's Party (PPP) led government in the Azad Jammu and Kashmir (AJK) decided to lodge a protest against the Pakistan Muslim League-Nawaz (PML-N) led federal government for its increasing involvement and bans on recruitment and development projects. According to sources, the AJK Prime Minister Chaudhry Abdul Majeed is convening a meeting of the cabinet in which he will take the ministers into confidence on the protest programme. The AJK government holds Federal Minister for Kashmir Affairs Barjees Tahir responsible for the cessation of its harmony with the centre. Sources noted the federal government has postponed the implementation of Rs800m development package for the AJK. Implementation of Rs10.5b annual development programme has also been placed on the back burner. The education policy given by the federal government five years back stated the primary schools will be upgraded. However, even the first phase of this programme has not been implemented. There will be elections for the AJK in July 2016. Prime Minister Nawaz Sharif had announced projects of billions of rupees during his visit to AJK in September 2015.

### **“NOC to be made compulsory for tourists”**

The government of Azad Jammu and Kashmir (AJK) decided on November 14 that a No Objection Certificate will now be made mandatory for the adventure tourism in the area; a notice in this regard will soon be issued by the tourism department. Tourism Department of AJK has asked people from all the four provinces who want to scale peaks, raft, paraglide or rock climbing in the area to first get an NOC for the concerned department. Earlier in September 2015, Islamabad based climbers Usman, Imran and Khurram aged between 30 and 35 years had gone missing while trying to scale the Sirwali peak in the Kel area of Neelum Valley. On

September 16, the Neelum District administration called off the rescue operation and declared both the missing climbers dead who had gone Neelum Valley for climbing without any NOC.

### **“Key suspect in Nanga Parbat massacre escapes police raid”**

A key suspect in the 2013 massacre of foreign climbers in Pakistan is on the run after he hurled grenades at officers who were pursuing him, injuring 10 of them, officials stated on November 16. The suspect, named by police as Rahimullah, has a bounty on his head of one million rupees (\$10,000) over his alleged involvement in the attack on the base camp at Nanga Parbat, Pakistan's second highest mountain. Gunmen dressed in police uniforms stormed the camp and shot dead 10 foreign mountaineers and their guide in an assault that shocked the world and scarred the country's climbing tourism industry. Police had tracked Rahimullah down to a house in the Tangir area in northern Gilgit-Baltistan province and cordoned it off, a local police official noted on telephone. "We raided that house and warned the militant to surrender, but he hurled grenades over the raiding team," Mehr Ghani stated, referring to Rahimullah, who also goes by the alias Azizullah. "We retaliated and the exchange of fire continued for the whole night. When we entered the house in the morning, the suspect had already escaped." Ten officers were injured in the stand-off and a male relative and a woman who were in the house were taken into custody, Ghani noted. Muhammad Wakeel, spokesman for the local police, stated that Rahimullah is one of seven high profile suspects who are still being hunted by investigators in connection with the 2013 attack.

### **“Army trains force to deal with terrorism”**

The Pakistan Army has trained a special high altitude force in GilgitBaltistan to encourage

foreign tourists to visit the region. A ceremony was held on November 18 to mark the completion of the training. G-B Chief Minister Hafeezur Rahman attended the event as a chief guest. Force Commander Major General Asim Munir was also present on the occasion. On November 18 after the ceremony, Rahman stated the force was trained by the army because traditional training was not adequate enough to protect climbers at high altitudes. "In the past, a series of reservations were expressed over police performance," he noted. "However, with a force that has been trained diligently, similar complaints can now be avoided." According to Rahman, the new force has been trained by Special Service Group commandos and is equipped with special gear and equipment to respond to emergencies.

### **Saira Begum, “How to curb intolerance and extremism from GB?”**

In retrospection, I have a vague but hazardous memory of my childhood. I was coming back from school in a frosty winter morning when I heard uninterrupted firing for several hours. The dismal state of affairs was indicating something serious but I was unaware of what was going on until our car was intercepted on the road and warned us to move back. Then, one of the men broke the news of murder of Zia-ud-Din Rizvi, leading Islamic Shia scholar in Gilgit Baltistan. During this turmoil, several innocent people lost their lives without being indulging in any conflict. Later on, curfew was imposed for couple of weeks and business in the vulnerable disputed area came to halt. For months, Shia, and Sunni conflicts became talk of the town, from a ten years kid to a grown up man, everyone was discussing and striving hard to surpass in breeding extremism, conflict and hatred in society. Meanwhile, schools re-opened after a month but there was a wave of fear all around, the fear of indoctrinating young minds with religious extremism and hatred. Diabolical forces succeeded in inculcating extremism, fundamentalism, sectarianism and intolerance which have damaged



peace and tranquillity of Gilgit. Anyhow, this was my first memory of knowing about Shiite and Sunni cleavages that rifted peace of the area apart, before this, I was not cognizant with any sectarian cleavage. Young generation of my age has been poisoned with this kind of hatred.

### **“Gilgit-Baltistan part of JK: PaK President”**

Pakistan administered Kashmir (PaK) President Sardar Muhammad Yaqoob Khan stated that Gilgit-Baltistan (GB) were part of the state of Jammu and Kashmir and any change in this position could deal a blow to the stand of Kashmiris as well as Pakistan on the lingering dispute. “I have always spoken for the rights of the people of Gilgit-Baltistan, but it's not an appropriate time to discuss proposals that can dent our principled stand on Kashmir issue,” he stated, while talking to a delegation of Capital Journalists Forum on November 19. “Instead, we should devote ourselves to the settlement of the larger issue, which has far reaching benefits more for Pakistan than the Kashmiris,” he added. He recalled that during his visit to the US to attend OIC contact group meeting, Sartaj Aziz, advisor to PM Pakistan on foreign affairs, told him that a committee was being constituted on Gilgit-Baltistan status issue, but his (Khan's) response was that this issue should not be discussed there.

### **“Mir Ghazanfar Ali Khan new GB governor”**

Mir Ghazanfar Ali Khan, a veteran politician and close associate of Prime Minister Nawaz Sharif, has been appointed as the governor of Gilgit-Baltistan on November 20. Ghazanfar, a sitting member of the region's legislative assembly from Hunza district, is considered to be a close friend of Prime Minister Mian Muhammad Nawaz Sharif. Earlier, Minister for Gilgit-Baltistan and Kashmir Affairs Chaudhry Barjees Tahir was appointed governor of G-B on February 15, 2015 after the amendment of

G-B Governance and Self-Rule Order. The president has approved, on the prime minister's advice, the appointment of Mir Ghazanfar Ali Khan as Governor Gilgit-Baltistan. He also served as the chief executive of the then Northern Areas' Legislative Council (NALC).

### **“Govt likely to remove PPP condition”**

The government is likely to waive off the Central Development Working Party's (CDWP) condition regarding Public-Private Partnership (PPP) for the construction of Hanzil Hydropower project at Gilgit. Gilgit Baltistan has requested the federal government to remove the CDWP condition of Public-Private Partnership (PPP) for the construction of Hanzil Hydropower project, the working paper of the project noted. The proposed project is a medium head run of the river scheme which envisages construction of 20 MW hydropower project located on the right bank of Gilgit River, a tributary of Indus River at about 12 km from Gilgit town.

The total cost of 20 Megawatts (MW) Hanzil Hydropower Project, would be Rs 6.248 billion and would be completed in four years. Rs 1 billion have already been allocated in the PSDP 2015-16, while the project has a Foreign Exchange EC component of Rs 948.37 million. The Ministry of Water and Power Gilgit Baltistan requested that the condition of PPP mode be deleted from the CDWP decision because PPP mode is not possible in GB due to various reasons.

The reason forwarded by Gilgit Baltistan (GB) government for waiving off the CDWP conditions includes: National Grid is not connected to GB and Nepra jurisdiction cannot be extended to the area. There also exists no local policy for PPP or IPP mode. The load and diversity factor are very low in

the area as there exists no heavy industries due to which repayment to the investors through tariff is not possible. In October 2013, a meeting was held on the request of GB where the representative of IPDF, Finance Division also acknowledged that PPP mode is not viable option for the implementation of these projects.

## **“Trophy hunting programme: G-B sets \$67,500 as hunting fee for markhor”**

According to an official of G-B wildlife department, auctioning trophy hunting was a step towards conserving wildlife. Speaking on October 30, the official further stated the initiative will lead to the implementation of more techniques of preservation.

## **“Gilgit-Baltistan Seeks Share of CPEC Pie”**

The government of Gilgit-Baltistan urged the federal government to initiate some development projects for the territory under China-Pakistan Economic Corridor (CPEC). The federal government has so far signed at least 51 memoranda of understanding (MoUs) of different energy and development projects with China but none of them is for Gilgit-Baltistan. A major chunk of the funds is allocated for construction and installation of new power projects to overcome the ongoing energy crisis. Gilgit-Baltistan Minister for Works Dr Muhammad Iqbal noted on October 30 that his government has taken up the issue with the federal government as zero projects under the CPEC for GB is a clear cut case of discrimination against the

people of the territory. “The federal government has promised to construct two economic zones in Gilgit-Baltistan but these projects are not part of the CPEC,” he stated. The Minister further stated the federal government should not ignore the people of the territory “who need development projects under the CPEC the most. We hope the federal government would pay heed to our demands and include the territory in the CPEC.” A senior government official, however, stated the government has refrained from announcing any projects for the Gilgit-Baltistan under the CPEC as it does not want to make the entire corridor controversial.

## **“Six-year delay increases cost by 157pc to Rs 8.6b”**

*The Nation, November 7, 2015*

The delay of six years in the implementation of 26MW Shagharthang Hydropower has increased the cost of the project by 156.7 percent from Rs3.35 billion to Rs 8.6 billion. The shortage of funds, red-tapism, depreciation in rupee value, location in low priority areas etc are the main reasons for the cost escalation and it is a routine matter with most of the hydropower projects, an official source noted. The delay, in the projects, is costing hundreds of billions of rupees loss to the national exchequer annually, the source added. According the working paper, the project was originally approved on August 20, 2009 with the cost of Rs 3.35 billion which reached to Rs 4.84 billion in 2011 and finally got the CDWP approval at Rs8.6 billion. Out of the total cost of Rs 8616.015 million, the Foreign Exchange Components (FEC) is Rs 71843.13 million. The project will be financed from Multi tranche Financing Facility, Tranche-III of Asian Development Bank (ADB) loan provided from RESDIP and will be completed in four years. The

total allocation for the project in the PSDP 2015-16 is Rs 100 million. The main reason for the delay in the construction of 26MW Shagharthang Hydropower was its financing issue as in 2013 the Economic Coordination Committee (ECC) of the Cabinet refused to take on the responsibility for repaying foreign loans sought by Gilgit-Baltistan. In 2013, the matter of re-lending and repayment of loans by the Gilgit-Baltistan government for, 26 megawatts hydropower project to be developed in Shagharthang Skardu, came to ECC for discussion.

Hydropower Project located on Indus River 83 kms from Gilgit to the Planning Commission for approval. In a report to the Gilgit Baltistan government, WAPDA Chairman Zafar Mahmood stated the Prime Minister attaches highest importance to the exploitation of hydropower potential, which exists in Gilgit-Baltistan. According to Mahmood, Pakistan has the potential to produce 100,000 megawatts of hydroelectric power. Of this, the identified potential stands at 60,158MW, but only 6,919MW has so far been tapped. He stated the Indus Cascade, located in Gilgit-Baltistan and Khyber Pakhtunkhwa is the future energy corridor for Pakistan. PC-I of the 7100-MW Bunji Hydropower Project PC-I consisting of Land Acquisition, Preliminary activities, Civil & Electro Mechanical works has been sent to the Planning Commission for approval. PC-I of some of the projects on Indus Cascade are yet to be readied. "To execute such mega projects in private sector, WAPDA has submitted a policy to the Ministry of Water and Power for approval", he further added.

### **“CPEC to cause unemployment in Gilgit-Baltistan”**

The much-publicised China-Pakistan Economic Corridor (CPEC) may benefit many, but it will render more than 10,000 people of Gilgit-Baltistan (G-B) jobless once the existing dry port is relocated from Sost in G-B to Havelian in Hazara division of Khyber-Pakhtunkhwa. There is no industry in the whole of G-B and more than 10,000 people are associated with the Sost dry port including businessmen, transporters, hoteliers and other people, whose livelihood is directly and indirectly linked with the port. It attained the distinction of teaching hospital after the emergence of Mohtarma Benazir Bhutto Shaheed Medical College in Mirpur about 4 years ago. Dr Bashir stated that at the same time DHQ hospital had so far been furnished with all requisite services for indoor and outdoor patients. ### **“Proposal to introduce pre-paid electricity meter system in AJK”**

The AJK government is seriously contemplating to install pre-paid electricity meter system in AJK to

ensure absolutely correct billing, official sources revealed. The sources noted that the plan for installation of pre-paid electricity meter system also involved the introduction of meter reading card. The sources further noted that the government is taking these steps in the light of frequent complaints by general consumers of electricity in the AJK about wrong billing. Besides initiating the phased plan for introduction of pre-paid electricity meter system, the government is also contemplating to computerise the billing of electricity. Monitoring teams, headed by SDOs, have been established at all district and Tehsil levels to receive public complaints about wrong and over billing from the consumers. At present the electricity bills for all sorts of consumers are compiled manually by Revenue Wing of the State Electricity Department. Complaints by the consumers about supply of incorrect electricity bills have become a routine. The sources disclosed that the government has also decided to keep the posting of a line man or a meter reader in an area only for a period of three-months. No line man or meter reader could complete more than the stipulated three-month period in any area and their transfers would be made in rotation under the proposed new policy, the sources noted. The government has also directed the State Electricity Department to gradually change all of the old meters and power supply lines.
